

Alcohol Ordinance: Responsible Beverage Service Training

Municipality, County, & Population	Ordinance Language & Ordinance Link
Edwardsville, IL Madison County Population: 24,293	Section 6-57 Licensee/employee education required. Language included to specify responsible beverage training must be a live training and an ILCC approved BASSET program. Identifies who needs training and when training must be completed.
Des Plaines, IL Cook County Population: 58,364	Section 4-4-19 Alcohol awareness training language. Language included for owner and manager to successfully complete an alcohol awareness training program accredited by the state or conducted by the police department.
Highland Park, IL Lake County Population: 29,763	Section 119.410 Responsible Alcohol Service Training Required. Language for training requirements for manager and employees of a local liquor licensee. Language includes successful completion of a BASSET program or TIPS program within ten days of beginning employment. (C) includes language for restrictions on sales by untrained personnel.
Urbana, IL Champaign County Population: 41,250	Section 3-51 BASSET Training. Comprehensive definitions provided for server, BASSET, BASSET certificate, establishment, liquor licensees, and BASSET training programs. Penalty language is also included.

Naperville, IL DuPage and Will Counties Population: 141,853	Section 3-3-8 Personnel restrictions for liquor licenses and BASSET requirements. Provides language to identify requirements for those who provide security services and defines what security services includes.
Buffalo Grove, IL Lake and Cook Counties Population: 41,496	Section 5-20-105 Language for bring your own bottle (BYOB) license and BASSET qualified employee requirements.
University Park, IL Cook and Will Counties Population: 7,129	Section 808-21 Required training for servers of alcohol. Ordinance begins with language as to why the Village is requiring training for servers of alcohol.
Franklin Park, IL Cook County Population: 18,333	Section 3-2-16 Mandatory training for all persons who sell and serve alcoholic beverages. Language included that in addition to BASSET training, all local liquor licensees shall attend on an annual basis the Franklin Park local liquor control commission seminar conducted by the village of Franklin Park local liquor control commissioner and the village of Franklin Park police department in conjunction with the Illinois Secretary of State.
DeKalb County, IL Population: 105,160	Section 2-27-2 Certification: Beverage alcohol sellers and servers education training program. Language encouraging all future county board chairmen become BASSET certified during their first year of service as the county liquor commissioner.
Rolling Meadows, IL Cook County Population: 24,099	Section 6-83 Required training and education for sellers and servers. Language included for requirement of establishments to post in an appropriate area conspicuous to alcohol servers an intoxication awareness chart.
New Lenox, IL Will County Population: 24,394	Section 6-120 Training requirements for beverage requirement alcohol sellers and server's education and training program (BASSET). Language noting when a BASSET course might be repeated, as well as language regarding violations.

Plainfield, IL Will County Population: 39,581	Section 4-25 BASSET certification required. Language identifying costs associated with a licensee's compliance with BASSET training required under this article shall be paid by the licensee.
