Our History

Prevention First was first known as the Illinois Prevention Resource Center, created in 1980 to address the alarming increase in youth drug use occurring at the time. In 1987, PRC incorporated as a non-profit organization and changed its name to Prevention First in 1994.

Since then, Prevention First has trained hundreds of schools and community groups in use of effective substance abuse prevention programs and practices, opened the state's first training and resource center to help schools establish effective Student Assistance Programs, and became the fiscal agent for Illinois' Students Against Destructive Decisions (SADD). We have also trained hundreds of healthcare professionals in educating women regarding the dangers of drinking alcohol while pregnant.

Today, Prevention First is Illinois' ONLY nonprofit resource center specializing in preventing alcohol and other drug use among youth and pregnant women.

Why Prevention

According to the National Institute on Drug Abuse, research has demonstrated that research-based drug abuse prevention programs are cost-effective. Each dollar invested in prevention achieves a savings of up to \$7 in areas such as substance abuse treatment and criminal justice system costs, not to mention their wider impact on the trajectory of young lives and their families.

Each year, drug abuse and addiction cost taxpayers nearly \$534 billion in **preventable** health care, law enforcement, crime, and other costs.

Over 20 years of research demonstrates that prevention interventions designed and tested to reduce risk and enhance protective factors can help children at every step along their developmental path, from early childhood into young adulthood.

Our Programs and Services

Training and Technical Assistance is for community-based organizations, coalitions, schools, law enforcement and others working to prevent drug use in their communities. As the training contractor for the Illinois Department of Human Services, we work with the Department's local grantees throughout Illinois to ensure that their drug prevention programs use strategies that are proven through research to reduce youth drug use.

The Student Assistance Center (SAC) works with public and private schools to support their prevention, intervention and other programs that address non-academic barriers to student success such as violence, mental health issues, relationship issues and substance abuse. The mission of the Center is to develop capacity in schools to implement a systems approach to delivering non-academic services to students and to improve school climate.

The **Illinois Department of Corrections (IDOC)** has relied on the knowledge and experience of Prevention First for training its correctional staff in various substance abuse-related disciplines since 1989. The primary goals of the program are to develop a core group of trained professional staff who are able to identify offenders with substance abuse programming needs, provide drug education services to specified offenders, and make appropriate recommendations and referrals for offenders in need of substance abuse treatment.

Education and public awareness to prevent Fetal Alcohol Spectrum Disorders (FASD) Prevention First provides WIC Certified Health Professionals with training and technical assistance in the skills and knowledge they need to successfully prevent Fetal Alcohol Spectrum Disorders (FASD) among the women they serve.

Illinois Students Against Destructive Decisions (SADD) provides training, technical assistance and support to over 220 chapters in Illinois. It also provides assistance to schools that are interested in starting a chapter. This initiative's mission is to provide students with the best prevention tools possible to deal with the issues of underage drinking, other drug use, risky and impaired driving, and other destructive decisions.

Our website provides information on the latest trends and education related to youth substance abuse and related issues, fact sheets, and links to important resources and related topics.

Financial Highlights

Prevention First is dedicated to providing the highest quality services while remaining fiscally responsible for the funds that we receive from both the private and public sectors. We are committed to balancing the needed services with prudent spending and leveraging limited resources.

During FY2014, Prevention First spent \$2,479,916 preventing alcohol and drug abuse in Illinois. Eighty cents of every dollar

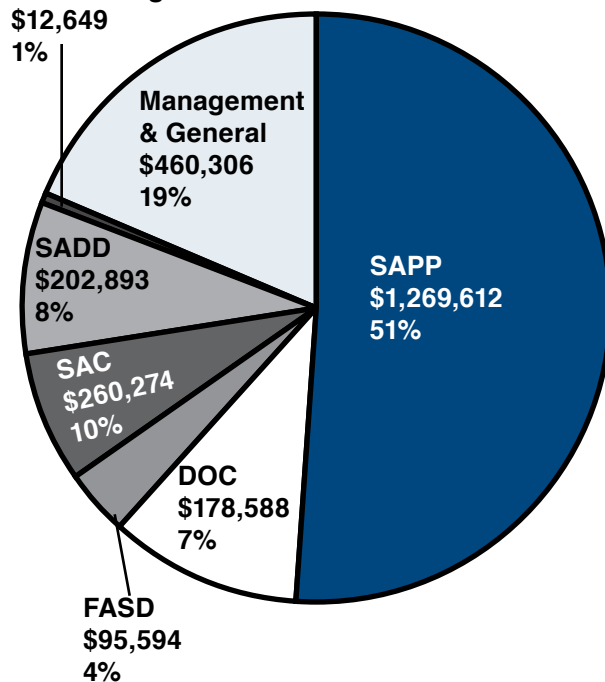
spent, or \$2,006,961, went towards program services, while the remainder was accounted for by management and general expenses of \$460,306 and fundraising costs of \$12,649.

Approximately 94 percent of these expenditures were funded by the government, with the remaining funding provided by private grants, public support and other revenue sources. Approximately one percent of these expenditures (\$12,445) were funded by a private grant from State Farm.

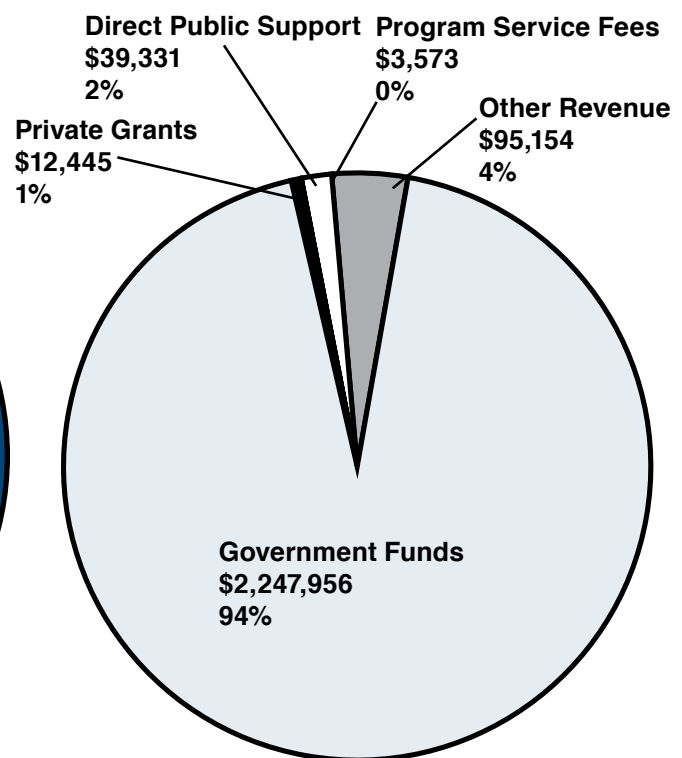

Key Accomplishments

- Prevention First provided 51 trainings to Substance Abuse Prevention professionals throughout Illinois.
- More than 900 individuals received SAPP training, and 129 unduplicated personnel received technical assistance from Prevention First.
- Prevention First developed new curricula for eight online or classroom trainings and four webinars covering aspects of substance abuse prevention.
- Five trainings were provided to 224 IDOC correctional counselors, casework supervisors, parole agents and wardens. Prevention First also provided financial and administrative support to 69 certified IDOC staff who maintained their CADC credentials by attending two annual conferences.
- More than 300 WIC professionals were trained in educating women about the dangers of drinking while pregnant.
- The Students Against Destructive Decisions (SADD) program provided 35 trainings, and served 170 schools and 4,500 Illinois students.
- The Student Assistance Center provided 23 training programs to 35 schools. Resources and technical assistance were provided to more than 160 schools.
- Prevention.org provided information to more than 11,000 users who had nearly 104,000 page views.
- Prevention First has collected an average of 900 pounds of unused prescription drugs each year over the past five years, ensuring their safe disposal.
- Five national media campaigns were promoted in an effort to increase public awareness related to substance abuse.
