Shannon Alderman – IDOT

Jennifer Martin – IDPH

The Illinois Department of Public Health, in collaboration, with the Illinois Partnership for Safety (IPS), wanted to learn more about the injury, violence, and suicide prevention (IVP) topics local communities have identified as a priority area. There are a couple of community needs assessments for us to refer to. We particularly were interested in the assessments done by local hospitals and local health departments (LHD).

This has been a multi-step process. First, IDPH identified which LHD and hospitals had identified an IVP topic (or shared risk factor – including substance abuse) as a priority. Second, an IPS member read the local [hospital community health assessments](#) for each of those hospitals to learn more about the what they identified were 1) specific gaps and 2) possible root causes. Currently, IDPH is analyzing the information gathered from the hospitals to answer two questions 1) Of the hospitals that picked a certain topic area, what did they identify as their gaps in service and possible root causes? 2) For each county, what did the hospitals in that county list as their priority topics, gaps in service, and possible root causes?

The next phase will look at community assessments by local health departments. As results are released, IDPH will share the information with stakeholders to help inform planning purposes.
